### 2. CONFIRMATION OF MINUTES

### 2.1 Minutes of the meeting of CapeROC 24 November 2016

**RECOMMENDATION:** That the minutes of the meeting of the Capes Region Organisation of Councils held 24 November 2016 be confirmed as a true and correct record.

The minutes of the meeting held on the 24<sup>th</sup> of November 2016 were confirmed.

### 3. PRESENTATIONS

### <u>3.1 Tony Brown (Executive Manager Governance and Organisational Services) –</u> WALGA

Regional Subsidiaries Legislation. The regulations have been drafted and WALGA have a number of concerns, particularly over the restrictions on commencing trading undertakings and entering into land transactions. They will be advocating changes to the legislation after the next state government election – will use South Australian legislation as an example. (See attachment)

Removal of Motor Vehicle concessions for local government. This will not only impact on local government (some of whom may have to cover the expected losses with a rate increase of 2-3%), but will also hurt the motor vehicle trader industry.

WALGA position on Rural Fire Service. Support – tied up with ESL review. Will get update for CapeROC. CoB had preliminary meeting – were promised to be part of the consultation process, and then the Collie announcement made. AMR BFAC not supportive – happy with DFES model with minor changes.

ERA – review of emergency services. Feedback required by 10<sup>th</sup> of March – need to go back to original arrangement and see what has changed.

Gift provisions. WALGA proposing changes to the government, including lifting the limit from \$300 to \$500, and only being required to declare if it relates to a staff member's role. The working group included a staff member from the Department of Premier and Cabinet so they are aware of the complexity.

Corella management. A lot of work has been done – Tony Brown will ask Mark Batty to provide an update to CapeROC.

Circulated update. Points to note:

- Entry statement change to art trail now a piece of major public art at Vasse and other pieces which will be based on the Noongar calendar with the main piece linking. Working with Koomal Dreaming. Some of the industry concerned with Vasse location and scale of major piece. Need to get commitment and clarification from their own industry. McDonalds part of the concern. Could place on private property which could solve some of the issues.
- Partnerships trying to engage with arts industry.

• Timeline – not going to happen in time for 50<sup>th</sup> anniversary – this has been acknowledged.

50 year anniversary – Cabin Fever event will probably now be associated with it. Were going to do series of short films, book coming out, other smaller events. Positive development with Cath Oates as the new president. The Association is working on establishing a greater marketing presence, promoting the region, and establishing relationships with different agencies – looking for the opportunity to have a more integrated approach across the region ie tourism, wine, chambers of commerce, which is supported by CapeROC. It was suggested that Cath be invited to the next CapeROC to outline their current focus and achievements over the last few months.

### MR Wine 50th Anniversary (\$20k) - Proposed allocation of \$20,000 funds:

- \$20,000 funds are to be allocated to two important 50<sup>th</sup> Anniversary projects that are directly related.
- \$5,000 to go toward "A Thousand Fathers" a detailed historic publication showcasing the Wine Industry –both Council's will be acknowledged in the book
- \$15,000 to go toward regional video footage for the 50<sup>th</sup> Anniversary signature event the "Decade Tastings" Masterclass - both Council's will be acknowledged in the films.

Budget for 2017-18 – need to identify projects. Could get some direction from the State government. Currently seem to be focussed on tourism related events, which are already funded by the events and tourism budgets that the individual LG's have. Examples of what could be included could be research into short stay accommodation, EDS – initiatives that have spill over effect tourism and agriculture ie food and agriculture summit. Need a bigger geographic scope, and the agriculture sector needs better representation.

### IN BRIEF

The Western Australian Government reviewed the *Western Australian Trails Strategy 2009-2015* and it is anticipated that the new *Western Australian Strategic Trails Blueprint 2017-2021* will be released later in 2017. Both AMRS and CoB have several well used trails and trail development strategies. In order to develop a consistent and integrated approach to trail development within the region it is proposed a regional trail strategy be prepared.

### BACKGROUND

The Department of Sport and Recreation coordinated the development of the *Western Australian Strategic Trails Blueprint 2017-2021* (Blueprint) which is an overarching guide for consistent and coordinated planning, development and management of quality trails and trail experiences across Western Australia. It is anticipated that the Blueprint will be released later this year. The Blueprint supersedes the earlier *Western Australian Trails Strategy 2009-2015*. The Blueprint covers the following trail types: bushwalking/urban walk, mountain bikes, cycle, trail bikes, equestrian, paddle, snorkel, 2Wdrive and 4Wdrive. One of the key strategic directions flowing from the Blueprint is the development of an integrated and consistent approach to trail planning at the state, regional and local levels.

### COMMENT

Benefits of trails

- Improve awareness and appreciation of the natural environment and support for its conservation and protection.
- Encourage outdoor physical activity leading to improved physical and mental wellbeing and a reduction in lifestyle diseases and associated medical costs.
- Facilitate protection and appreciation of cultural and historic areas by providing access.
- Increase opportunities for social interaction and development of community identity through participation in trail activities, maintenance and conservation.
- Provide low cost facilities for recreation accessible to many different groups in the community.
- Provide economic benefits for employment in trail development, management, maintenance, and events.
- Facilitate tourism growth to trail destinations.

### What both councils have in place

- The Busselton to Dunsborough shared path is complete along Geographe Bay. The path continues east of Busselton Jetty to Port Geographe, then on to the footbridge spanning a Port Geographe canal and then on to Wonnerup (with possible extension on to Wonnerup House)
- Margaret River to Gnarabup shared path
- CoB Bike Plan (2010) NOTE: This plan will be reviewed with the Department of Transport
- ARMS Bikeplan DoT grant awarded for preparation in 2016/17 & 2017/18
- <u>South West Mountain Bike Master Plan</u> Trails identified in the district... ID 21 <u>Meelup Regional</u> <u>Park Mountain Bike Trail</u> and ID 26 Whicher Range (with Middle Earth being a possibility with further development), Bramley National Park MTB (trails recently completed and planning is underway for additional walk and MTB trails)
- AMRS Bridle Trails Masterplan (2014) trails in Shire reserves and on DPaW estate
- Busselton Horse Trails Master Plan 2016-2020. The final plan has been prepared but is yet to be endorsed by the Council. The Council supported an application by South West Capes Bridle Trails Association to Lotterywest to fund the master plan document

- Cape to Cape Track
- Munda Biddi Trail Passes from Donnybrook, through Jarrahwood and on to Nannup
- Augusta to Busselton Heritage Trail audit recently commissioned by AMRS
- Wadandi Track This is a joint project with the Shire of Augusta Margaret River and was initiated by the National Trust WA
- Rails to Trails Apart from the Wadandi Track, <u>Council Policy 011</u> proposes a network of trails over the former WA Government Railway network through the district, including Boyanup to Busselton and Wonnerup to Nannup. NOTE: The <u>Shire of Capel Trails Master Plan</u> supports the proposal and the link from Jarrahwood to Nannup already forms part of the Munda Biddi Trail
- Coastal trails in Augusta Ellis Street Jetty to Augusta Boat Harbour (one missing section), proposed southern extension to Cape Leeuwin, possible northern extension to West Bay
- Bushland reserves The CoB manages various bushland/conservation reserves such as Meelup, Ambergate and Carbunup with walk trails. DPaW also manage conservation reserves with trails. Provided these trails are managed well, they might be better promoted
- Busselton Wetlands Trails Master Plan Stages have been completed
- Yallingup Trails There is a <u>network of walk trails</u> around the Yallingup townsite with connections to the Cape to Cape Track

City of Busselton

- Commonage Precinct PAWs A network of PAWs links Vasse Yallingup Siding Road with Yallingup
- Trails in National Parks (DPaW estate)
- Potential for other walk/cycle/drive/dive trails includes historic, heritage, bird watching (bird hides), etc. with some definition and promotion

<u>Issues</u>

- Uncoordinated approach to trail planning and development.
- Lack of integration between trails.
- Lack of consideration of all trail types either mode specific or shared.
- Conflict between trail user groups.
- Environmental impacts of trails.
- Lack of funding for implementation of trails.
- Unauthorised uses
- Providing for trail bike riders
- Trail promotion
- Involving community, interest groups and business

### Funding

Lotterywest manages the Trails Grants Program which provides funding support for community trails planning, construction and promotion projects. Guidance to applicants during the application process is provided by the Department of Sport and Recreation and Lotterywest.

### RECOMMENDATION

That CapeROC gives in principle support for \$30,000 to be allocated from next year's budget to employ a suitably qualified consultant to prepare a Capes Regional Trails Strategy and \$15,000 from each Council's budget.

- Can include independent board members:

## Regulations

- Submissions on Regulations late 2016
- WALGA Submission:
  - Principle of 'minimal regulation'
  - Subsidiaries should be governed by their Charter
- Regulations contain significant restrictions:
  - Restriction on Land Transactions
  - Restriction on Trading Undertakings
  - Restriction on Borrowing



## **Regulations – Restriction on Land Transactions**

Regulation 8:

- A regional subsidiary cannot ... enter into a land transaction.
- Land transaction means an agreement, or several agreements for a common purpose, under which a local government is to —

   (a) acquire or dispose of an interest in land; or
   (b) develop land;

"acquire" has a meaning that accords with the meaning of "dispose"; "dispose" includes to <u>sell</u>, <u>lease</u>, or otherwise dispose of, whether absolutely or not;



## Regulations – Restriction on Trading Undertaking

Regulation 8:

- A regional subsidiary cannot commence a trading undertaking.
- Trading Undertaking "means an activity carried on by a local government with a view to producing profit to it, or any other activity carried on by it that is of a kind prescribed for the purposes of this definition."



## **Regulations – Restriction on Borrowing**

Regulation 11 – Power to Borrow:

- (1) A regional subsidiary may borrow money from one or more of the participants to enable the regional subsidiary to perform its functions.
- (2) A regional subsidiary cannot borrow money otherwise than under subregulation (1).



## **Applications for Regional Subsidiaries**

Potential uses:

- Back-office functions e.g. finance or asset management
- Regional service delivery e.g. ranger services or building services
- Regional grant administration / regional project management
- Regional tourism promotion

Support:

- Assistance to Local Governments to establish regional subsidiary
- Provision of Model Charter

Advocacy:

- Regulatory change land transactions, trading undertakings, abilty to borrow
- Council Controlled Organisations






