CONDITIONS

1. Dog owners are reminded that dogs three months and over must be registered. The City also requests that dog owners inform the City immediately of any change in ownership, the death of a dog or change in address.
Failure to register a dog may result in \$500.00 penalty under the Dog Act.
2. In addition to the dog registration number tag, each dog must also have a tag on which is inscribed with the owners name, address and telephone number. These are obtainable from the RSPCA, Pet Shops and other sources.
3. The maximum number of dogs to be kept on any premises is two (2) over the age of three (3) months (dispensation can be given to keep more than two (2) dogs in some cases, but subject to a written request to the City and certain conditions being met).
4. To licence a dog under sterilised concessional rates, an owner or agent should either have a veterinarian's certificate or be prepared to sign a statutory declaration to that effect. Pro rata refunds can be made where licensed dogs become sterilised.
5. Dog owners must provide means on their property to effectively confine their dog. Means for effectively confining the dog within the premises does not include tethering. Any gates must have effective self-closing mechanisms.
