## **CONDITIONS**

- Dog owners are reminded that dogs three months and over must be registered. The City also requests that dog owners inform the City immediately of any change in ownership, the death of a dog or change in address.
- Failure to register a dog may result in \$5,000.00 penalty under the Dog Act 1976 (as amended). Failure to register a dangerous dog may result in a \$10,000.00 penalty under the Dog Act 1976 (as amended).
- Dogs must be microchipped (unless exempt) and must wear their registration tags at all times.
- The maximum number of dogs to be kept on any premises is two (2) over the age of three (3) months (dispensation can be given to keep more than two (2) dogs in some cases, but subject to a written request to the City and certain conditions being met).
- 5. To licence a dog under sterilised concessional rates, an owner or agent should either have a veterinarian's certificate or to be prepared to obtain a statutory declaration to that effect. Pro rata refunds can be made in some cases where licensed dogs become sterilised.
- Dog owners must provide means on their property to effectively confine their dog. Means for effectively confining the dog within the premises does not include tethering.
- 7. The registration fee payable in relation to a dog that is bona fide used in the droving or tending of stock shall be one quarter of the fee that would be otherwise be payable. For proof at registration you will be required to provide a statutory declaration.
