#### **EMERGENCY PREPAREDENSS EXERCISE**

#### Inter-Agency Desktop Emergency Preparedness Exercise for Harris & Wellington Dams

On Wednesday 20<sup>th</sup> April, the Water Corporation held a workshop to step through preparedness and response protocols for flooding scenarios associated with Harris and Wellington Dams.

This workshop was designed to involve the key external agencies such as DFES, Department of Water and Environmental Regulation, South West Police, Main Roads WA, Western Power, DBCA, Local Government, and Department of Communities all with responsibility in major flooding events. The focus of the workshop was to provide awareness of the Dam Safety and Emergency Plans for Harris and Wellington Dams.

# LOCAL EMERGENCY MANAGEMENT ARRANGEMENTS (LEMA) REVIEW OUTCOMES AND NEXT STEPS

The <u>Local Emergency Management Arrangements</u> (LEMA) Review is a partnership between the Department of Fire and Emergency Services (DFES) and WALGA, initiated in response to reports that current LEMA requirements are not fit-for-purpose for Local Government and that a new LEMA model is needed. From April to December 2022, WALGA engaged 100 Local Governments to identify LEMA strengths, weaknesses, and improvement opportunities in a consultation that included 10 in-depth interviews, 10 interactive workshops and an online survey.

WALGA's <u>LEMA Review Consultation with Western Australian Local Governments: Project Summary and Recommendations Report</u> summarises the key findings of the consultation process to date. A more detailed overview can be found in <u>WALGA's LEMA Review Issues Paper</u>, <u>LEMA Review Survey Report</u> and an independent <u>LEMA Review Workshop Consultation Report</u> prepared by <u>agdots</u>.

WALGA'S LEMA Review project informed the Draft LEMA Improvement Plan that has now been developed by DFES and presented to the LEMA Review Steering Committee. The Committee has approved testing to commence with the Local Government sector during April and May 2023 and then submit the final LEMA Improvement Plan to SEMC for endorsement in August 2023.

#### **GRANT PROGRAM UPDATES**

The State Emergency Management Committee (SEMC) oversees the distribution of grant funding to support activities that reduce disaster risk and enhance WA's resilience to disasters.

#### National Disaster Risk Reduction (NDRR) grant

The <u>National Disaster Risk Reduction (NDRR) grants program</u> is **now open** for projects that reduce disaster risk in Western Australia.

The NDRR grant program will make about \$2.5 million available in 2023 for projects that reduce disaster risk in Western Australia. Projects must contribute to achieving the objectives of the <u>National Disaster Risk Reduction Framework (NDRRF)</u> and the <u>WA Implementation Plan for the NDRRF</u> by reducing risks associated with at least one natural hazard. To be eligible, projects must reduce disaster risk and improve community resilience, rather than contributing to disaster relief, response, or recovery activities.

Organisations that are eligible to apply for NDRR grants are:

- local governments
- state government agencies
- government trading entities
- incorporated organisations
- not-for-profit organisations.

Projects with localised outcomes may apply for between \$10,000 and \$250,000 grant funding; there is no cap on funding for projects with State or sector-wide significance. Applicants must contribute at least 50 per cent of the total project cost in cash or in-kind.

Applications for the current round of the NDRR grant program are now open and close 12.00pm 29 May 2023. Assessments will take place in July 2023 with an anticipated announcement date in September 2023.

#### All West Australians Reducing Emergencies (AWARE) program

AWARE is an initiative of the Western Australian Government that invests in building capacity and preparedness activities at a local level, through a competitive grant. Only local governments are eligible to apply for an AWARE grant.

The 2023 AWARE grant round will distribute a total of \$200,000 for projects to:

- further the emergency risk management process
- facilitate capability-based exercises
- assist in reviewing Local Emergency Management Arrangements
- deliver emergency management training
- host or facilitate emergency management events or forums.

Projects may apply for between \$2,500 and \$30,000 grant funding. Local level risk assessment projects can request a maximum of \$4,000. Applicants must contribute 25 per cent of the total project cost in cash or in-kind. A local government may submit multiple projects for funding.

Local governments are encouraged to collaborate and submit joint applications.

Applications for next round of the AWARE grant program will open on 16 August and close on 20 September 2023. Assessments will take place in October 2023 with an anticipated announcement date in January 2024.

#### Incidents

There have been several incidents in the Donnybrook Balingup shire this year with some great support from across the region.

Both SES volunteers and staff have been also supporting the floods and cyclone in the Kimberley region, with several deployments.

#### International Fire Fighters Day Memorial

In honour of International Firefighters' Day on the 4th of May, DFES LSW will host a memorial service at the Busselton Fire and Rescue Station and the Bridgetown ICC. The service commemorates Western Australian career and volunteer firefighters who have lost their lives serving the community and included on the Fallen Firefighters' Honour Roll.

#### Training

Regional training has started increasing with several courses being conducted across the region.

#### Staff

New Area Officer Pat Dowling has started with our team. Pat (Paddy) will be looking stations on the Manjimup side of the Region. Paddy is from a career Fire and Rescue background and has moved to the Region from the metro area.

#### Transition of Brigades

As of the 1<sub>st</sub> of February, both Wallcliffe and Rosa Brook BFB have transitioned to DFES. All management of the brigades will now be via DFES, nothing will change in the coordination of response to fires and the normal working relationships between DFES and the AMR shire will continue as usual.

#### Community Engagement

Compiling a list of preferred communication methods for different communities to assist with community liaison during incidents

Bushfire Ready Facilitator training course delivered in April (Was open to fire volunteers who are interested in a community engagement role within their brigade)

Promoting the Bushfire Ready Program into Nelson district of the region; supporting the existing group facilitators in the Capes district

Delivered a fire safety session (covering bushfire and home fire safety) to Silverchain Social Centre in Bridgetown, with Area Officer Warren-Blackwood

#### Matters to be discussed:

Busselton Margaret River Operations and Security update

The Busselton Margaret River Airport (BRMA) has seen continual growth since the reporting cycle to the LEMC in both flight movements and passenger growth. A combination of both the increases in FIFO, closed charter operations and high patronage of the Regular Passenger Transport (RPT) service.

Operational and infrastructure changes in the reporting period have included an expansion of the long and short term car parking area with the addition of approximate 270 bays.

The departure lounge extension area has now been completed and is operational and is easing congestion within the sterile lounge area.

The central apron bay marking plan implementation has been completed and is now accommodating aircraft types from F100 up to A320N/B737 without turnout restrictions. The new bay marking allows for bays 9, 10 and 11 to facilitate up to A320/B737 operations while bay 8 is restricted to the F100 operations.


A review of the BMRA Wildlife and Hazard Management Plan has been undertaken by JASKO Airport Services and has been implemented..

# **Aircraft Movements**

The total number of scheduled services operating from the BMRA as of the end of the reporting period was 34 movements per week, with 31 Fly in Fly out (FIFO) closed charter and 3 RPT services.

Five airlines are operating from the BMRA with RPT and closed charter services utilising aircraft types from Dash 8/300 to Airbus A320 and Boeing 737/700 aircraft servicing destinations such as Melbourne and multiple mining operations across Western Australia. Private jet/charter operations have also increased utilising the Central and Southern Apron Bay 4.

There have been a total of 3909 aircraft landings for the 2022/23 financial year to date, with a total of 1296 landings in the category of 15,000 kgs and above MTOW (with 1169 of those on the 30,000kgs + category).



The Department of Fire and Emergency's large air tanker (LAT) Bomber Operations finish on the 31 March with the Helitak's remaining onsite until 7 April. Some key aspects of this year's operations have been:

- 1. LAT aircraft Bomber 132 and 139 responded to 15 incidents, a total of 97 sorties and a total of 80 hours flying time;
- 2. Helitacs flew 78 sorties and combined 129hrs flying time;
- 3. 1,248,000lts of water used for retardant mixing; and 4. A total of 31 personnel with SES contributing 500 hours in retardant mixing operations.

# **Passenger Numbers**

Total number of passengers for the 2022-23 FY to the end of March is 102,123 representing an increase of over 254% compared 40,205 passengers for the same time last year. The continued increase in passenger numbers can be attributed to the growth in RPT passengers (Jetstar services) and FIFO passenger numbers across all closed charter airlines servicing Rio Tinto, BHP and FMG, and Jetstar RPT services.

#### **Security**

Security screening under the Aviation Transport Security Act and regulations is performed for all RPT departing passengers. There has been 12,983 persons through the screening point at BMRA with total operating screening point hours of 241.75.

During this time items were surrendered, largely consisting of scissors, aerosols and lighter.

Two system tests was conducted by Transport Security Inspectors from CISC, and no other none compliances were noted for the reporting period.

The below table gives a breakdown of the screening activities over the reporting period.

#### **Emergency Exercise**

In accordance with the BMRA Aerodrome Manual and Part 139 (Aerodromes) Manual of Standards, a desk top emergency exercise was held on the 13/12/2023.

The exercise focused on testing the AEP around the setup of an IMT and associated facilities around a large scale protracted incident at the Airport.

Key emergency response stakeholders and airport operations staff participated in Operation Albatross to review and work through the most appropriate response outcomes to a large scale event.

A familiarisation was held at the same time with WAPOL and DFES to ensure that their staff / teams are familiar with the layout and emergency access points and other aspects of the aerodrome.

The evaluation report has now be finalised and submitted as (Attachment A) to this report to LEMC.

The Finalisation of the Airport Emergency Plan is in its final stages and will be provided to CASA and the relevant Emergency Services and Stakeholders on completion.

#### Queensland fruit fly

The Department of Primary Industries and Regional Development (DPIRD) is working to stem the spread of the significant invasive pest, Queensland fruit fly (Qfly), after a recent confirmed detection in Bayswater. A level 2 incident was called on 1 March 2023 after several male Qfly were detected in a residential part of Baywater, Perth. No Qfly have been detected in commercial areas or outside of the Perth metropolitan area

at this time.

Qfly is one of the most serious pests of fruit and vegetables in Australia, attacking over 300 species of fruit and vegetables and impacting a range of horticulture industries and access to valuable markets. While Qfly has been found in other areas of the country, Western Australia has remained free of the pest. #### Polyphagous shot-hole borer

Polyphagous shot-hole borer (PSHB) *Euwallacea fornicatus* is a beetle native to Southeast Asia. The beetle attacks a wide range of plants by tunnelling into trunks, stems and branches.

The Department of Primary Industries and Regional Development has been responding to the confirmed detections of an exotic beetle Polyphagous Shot-Hole Borer in the Perth metropolitan area.

Response activities include:

- Conducting surveillance to determine the distribution of PSHB
- Containing the pest to prevent further spread to non-infested regions within Western Australia
- Providing advice and information to residents, industry and other stakeholders
- Ensuring that all response activities are conducted safely, consistently and efficiently

# Recovery:

- Wheatbelt Development Commission Chief Executive Officer, Rob Cossart, has been appointed as the State Recovery Coordinator for the Kimberley floods
- DPIRD has established an internal recovery planning group to facilitate effective across-agency
  participation, and to assist in capturing and resolving emerging across-pillar impacts i.e. impacts
  for which the various pillars within DPIRD have responsibilities such as those relating to regional
  development, primary industries, biosecurity, horticulture, soil and grants.
- Departmental representation on the State Recovery Coordination Group (SRCG)
- The Department has representation on the Shire of Derby West Kimberley Recovery Coordination Group (RCG) and will provide representation on the relevant subcommittees, as required.
- DPIRD will facilitate available grants to primary producers in accordance with the Disaster Recovery

Funding Arrangements WA (DRFAWA).

DRFAWA:

Support measures are designed to assist in meeting the needs of primary producers whose assets or primary production business has/have been affected by a disaster for which DRFAWA has been invoked.

Category B - Assistance measures for primary producers may include grants for:

- Professional advice
  - Reimbursement of fees (maximum \$1,500) to obtain professional advice directly related to addressing issues arising from the declared natural disaster event
- Freight subsidy (reimbursement)

Primary producers can claim a maximum of 50% of the costs to the producer of transporting any of the following items as a direct result of a natural disaster:

- Livestock;
- o Fodder or water for livestock; or
- o Building or fencing equipment or machinery.
- Fencing (for livestock producers only)

Primary producers can claim 100% of the costs associated with any of the following:

- restoration/replacement of fencing (to pre-disaster standard) where the fencing has been deliberately dismantled or damaged due to counter disaster operations activities undertaken in order to combat the eligible natural disaster event; and/or
- o reimbursement of the costs of materials only (to pre-disaster standard) to repair/replace boundary fencing damaged/lost as a direct result of the eligible natural disaster event. The measure is only available where the fencing adjoins a major road/rail transport corridor and where the roaming of livestock may present a danger to the travelling public (i.e., the aim being to preserve public safety).

The applicant must demonstrate to DPIRD's satisfaction that at the time of the natural disaster event the property was being used to hold or agist livestock.

- Expression of interest for interest subsidy on a new loan to recover

  An interest rate subsidy may be available to primary producers for new loans:
  - to repair/replace assets lost or damaged / repair damage caused by the natural disaster event
  - o for carry on purposes to implement the next season's production program
  - or to replace livestock lost in the disaster for which the assistance measures under the DRFAWA have been activated

Category D – Freight Assistance Program

The Freight Assistance Program is the first of its kind in Australia, under the Disaster Recovery Funding Arrangements, and is designed to reimburse additional freight costs due to additional distance travelled while there is no bridge or river crossing at Fitzroy Crossing.

The assistance grants will support freight companies with the costs of necessary detours (including via South Australia and the Northern Territory) so the extra costs are not passed on to businesses and communities. The assistance program will remain available until a suitable road connection is re-established.

#### **Response to the Kimberley Floods**

- The Department of Communities (Communities) continues to provide emergency welfare services to residents impacted by the Kimberley floods.
- As of 26 April 2023:
  - 17 people remain in Communities' supported emergency accommodation in Broome and Derby.
  - 88 people are in Phase 1 Temporary Accommodation, including 27 in the Derby Hostel and
     61 in Humanihuts in Loanbun, Fitzroy Crossing and Bungardi.
  - Since the Disaster Response Hotline opened on the 11 January 2023 until COB 24 April 2023
     Communities has responded to a total of 1,792 calls.

#### **Response to Cyclone Ilsa**

• On 12 April the Department of Communities was activated to stand up 5 evacuation centre in preparation for Cyclone Ilsa. These included one in Port Hedland, one in Newman, one in Nullagine and two in Marble Bar. The Red alert was issued during the afternoon of 13 April with all teams locking in by 6pm. The final all clear was given at 1:22pm on 14 April, allowing individuals to leave the centres and go home. A total of 68 individuals were provided with meals, personal requisites, and accommodated in centres overnight: 28 in Port Hedland, 20 in Marble Bar and 20 in Nullagine.

# Training, Exercises, Webinars

- Several online webinars attended, including the Leave Nobody Behind series, Recovery Exercising Toolkit, and EMPA (Emergency Media and Public Affairs) 2023 Webinar Series.
- Attended inter-agency Desktop Emergency Preparedness Exercise for Harris and Wellington Dams hosted by Water Corp.
- Ongoing preparedness and response training will be provided to departmental staff, as well as interested stakeholders.
