

# **Council Policy**

Council Policy Name: Rail-Trails (including the Wadandi Track)

Responsible Directorate: Infrastructure and Environment Version Adopted

#### 1. PURPOSE

1.1. The purpose of this Policy is to:

- a. recognise the historical significance of the former government and private railway networks of the region;
- b. recognise the benefits attainable from a network of rail-trails throughout the region; and
- c. outlines the Council's commitment to the retention of the Crown land of the former government railways for rail-trail and recreational purposes.

#### 2. SCOPE

2.1. This Policy applies to the former government railways (including the alignment of the Wadandi Track) and the historic private railways within the district.

# 5. POLICY STATEMENT

## 5.1. The Council recognises:

a. the historical significance of the former government and private railways throughout the region;

- b. the recreational, heritage, social, environmental, transportation and economic benefits that a network of rail-trails would bring to the region; and
- c. the extent of the land of the former government railways that remains as Crown land, and the value of the land to the community.

## 5.2. It is the position of the Council that:

- a. the Crown land of the former government railways is retained as Crown land, as a contiguous corridor for non-motorised transport;
- b. the land is promoted, developed and managed primarily for rail-trail and recreational purposes, cognisant of the heritage and environmental values of the land;
- the City works collaboratively with the community, neighbouring local governments, government agencies, landowners and developers towards achieving a regional rail-trail network of high quality standard;
- d. the City will seek funding for the ongoing advancement of Rail-Trails as appropriate with available funding;
- e. the rail-trails integrate with other recreational and heritage trails within the district and the broader region; and
- f. within the district, the Busselton Jetty precinct forms the primary head of the rail-trails.

# 5.3. With respect to the rail-trail network, it is the position of the Council that, where practicable:

- a. the trails are constructed on the alignment of the original railway formation;
- b. where this is not possible, the trails are constructed within the reserve of the former government railway or, where that is not possible, as close to the reserve as practicable;
- c. the trails are made suitable for walking, cycling and compatible activities;
- d. the character of the railway formation mound is retained;
- e. the heritage characteristics of the heritage railway structures such as bridges, water crossings and formations are retained;
- f. the locations of former sidings are recognised along the rail-trails;
- g. at various stages, the trail allows for access by broad sections of the community;
- h. the trails provide for a range of interests and experiences including recreation, heritage, environmental and adventure; and
- i. the landscape of the reserve land be retained and enhanced so that it is in keeping with the natural environment.
