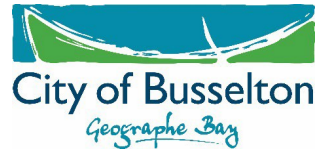

4. Vehicles are not to be driven on the sand dunes or any other place that is likely to cause environmental damage or erosion;
5. Vehicles are to be driven safely and in such a manner that is not likely to affect the enjoyment of other beach users.
