

## APPLICATION FOR PLANNING SERVICES

### How-to-Guide

This *How-to-Guide* is designed to assist customers in the lodgement of a Request for Planning Services by providing clear, step-by-step instructions.

#### What is a Request for Planning Services?

The City of Busselton offers a Request for Planning Services, enabling landowners, applicants, or interested parties to obtain detailed initial guidance on historic or proposed developments.

This service provides preliminary advice on specific issues or proposals, assisting you in understanding key planning considerations before progressing further. Please be aware that the information provided is offered in good faith as an initial consultation and does not constitute a formal assessment. It should not be interpreted as development (planning) approval or as an indication of the final outcome for your development.

#### What information may I request using this service?

landowners, applicants, or interested parties may request general information regarding a specific property or, including but not limited to:

- General property information (eg zoning, building height limit, Scheme controls etc...)
- General guidance on the relevant planning framework (eg Scheme, Policy/s).
- Land use permissibility within a particular zone.
- Approved development (works and/or land uses).
- Required minimum and average lot sizes that apply to a particular lot and/or zone.
- Respond to general questions from Bushfire Practitioners in relation to compliance with SPP 3.7 Bushfire and the supporting Guidelines. Copy of previous approvals and/or plans

Please note that due to the volume of applications for development approval currently under assessment, Planning Officers will not have capacity to undertake a full preliminary assessment of a particular development against the relevant planning framework.

#### How to I lodge a Request for Planning Services?

The following overview highlights the key steps involved in lodging your request.

##### 1. Complete the relevant form

Depending on the nature of your enquiry, you will need to complete the relevant form.

###### (a) Request Written Planning Advice and/or Zoning Certificate
