## 2. Local Emergency Management Arrangements Emergency Contacts and Resources Directory (Appendix 4)

Appendix 4 of the LEMA is the Emergency Contacts and Resource Directory – reviewed quarterly (aligned to the LEMC meeting schedule), updated and distributed accordingly.

The directory will be updated for this quarter and distributed to LEMC members with the meeting Minutes. A reminder this is a confidential document and not intended for public distribution.

#### 3. LEMC Terms of Reference

An internal review of the LEMC Terms of Reference was conducted. The revised Terms of Reference were adopted by the Council on 8 September 2021 and will be attached to the Minutes of this meeting.

#### 4. LEMC Meeting Frequency & Format

At the last DEMC meeting there was discussion around the effectiveness and frequency of LEMC meetings, as well as agency attendance. Vik Cheema, DFES District Emergency Management Advisor – South West) presented a fact sheet to the DEMC which is attached to this report.

Discussions have been held within the CoB with the following meeting model presented for discussion:

- a. number of LEMC meeting each year to be reduced from four to two;
- b. one meeting to be held in October/November each year (post storm season/pre bushfire season;
- c. the other meeting to be held in April/May each year (post bushfire season/pre storm season); and
- d. that at each of the meetings a maximum one hour desktop exercise be held as follows:
  - i. October/November meeting: bushfire scenario; and
  - ii. April/May meeting: storm scenario.

If supported by the LEMC, meeting Agendas will also be reviewed with a view to adding some of the headings included in the DEMC fact sheet (attachment 2). For example:

- a. confirmation of LEMA contact details;
- b. status of LEMA including Recovery Plans;
- c. desktop exercises as above;
- d. key achievements;
- e. funding opportunities; etc.

#### Officer Recommendation:

- 1. That the frequency of LEMC meeting be reduced from four to two each year;
- 2. That the first meeting be held on the first Tuesday of May each year and that the meeting include a one hour desktop exercise (storm scenario); and
- 3. That the second meeting be held on the last Tuesday of October each year and that the meeting include a one hour desktop exercise (bushfire scenario).

Matters to be discussed:

#### **Emergency Exercise**

Acknowledge this quarterly meeting of Busselton Margaret River Airport (BMRA) Emergency Committee (sub-committee of LEMC) as documented in the BMRA Aerodrome Manual, BMRA Emergency Plan and CASA regulations.

On 16 October 2021 the City of Busselton held Emergency Exercise 'ABORT TAKEOFF' at Busselton-Margaret River Airport. (Attached)

Aircraft movements into Busselton-Margaret River Airport have increased steadily with Fly in Fly out (FIFO) flights since 2010. With the expected commencement of Regular Public Transport (RPT) operations in February 2022 utilising larger aircraft with increased passenger payloads this presents significant implications in terms of the City of Busselton's LEMC's capacity to manage an aviation emergency response, including potentially large numbers of casualties involved in a single incident/accident.

Exercise 'ABORT TAKEOFF' was a field exercise involving all agencies nominated in the Aerodrome Emergency Plan. This exercise was conducted to practice or review all or part of the Airport Emergency Plan as required under the Civil Aviation Safety Regulations (CASR) in regard to an aviation emergency airside at the Busselton-Margaret River Airport.

Under CASA MOS 139 (Aerodromes), 24.01 (3)(d)(i)(ii).

  - (i) Following a test, an exercise or a real activation of the aerodrome emergency plan for the aerodrome; and
  - (ii) if subparagraph (i) does not apply, at least annually.

**State Emergency Management Committee** met on 1 October 2021. Please see attached copy of the SEMC Communique. Key points to note:

- Animal Welfare in Emergencies plan activation during the Wooroloo bushfire.
- Emergency Preparedness Report
- Allocation of \$1.3 million of the Mitigation Activity Fund (MAF) Royalties for Regions funding to treat priority bushfire risk on Crown land under the care, control and management of eligible LGA in WA.

Discussion Paper for the **Community Resilience Strategy** has been released. This Paper has been informed by community and stakeholder consultation undertaken over the past 18 months, and also by your input over the course of the project.

The Paper proposes a suite of action for further community consultation. It does not represent a position of Government but has been endorsed by the Minister for consultation. The launch of the Discussion Paper commences a new consultation phase to get feedback on the proposed approaches and develop some of the ideas more fully. The outcomes of this phase will inform a recommendation to Government regarding adoption of a final strategy discussion Paper for the Community Disaster Resilience Strategy is available

#### Preparing Australia Program

On 5 May 2021 the Prime Minister announced the Preparing Australia Program which will invest \$600 million toward households and communities to ensure they are better prepared for future disasters. Round one of the program is called Preparing Australian Communities Program for projects of local significance (PACP Local). The program will support projects that mitigate or reduce the disaster risk, impact and consequence associated with large-scale natural hazards.

Attached are the grant guidelines which were released recently, and have summarised the key information below:

- PACP Local (this round of the program) is for \$150 million available from 2021–22 to 2024–25.
- It will support locally identified and locally led projects that will improve the resilience of communities against three hazards bushfires, flood and tropical cyclones.
- The grant is coordinated by the NRRA and administered by Department of Industry, Science, Energy and Resources. The SEMC BU are providing a WA communications support role to the

NRRA.

- Applications will open on 10 December 2021 and close at 2pm WST on 6 January 2022 (5pm AEDT).
- WA have 24 priority LGA's across the three hazards bushfire, flood and cyclone. Some of these are across multiple hazards (pages 28 31 of the grant guidelines).
- All LGA's are still able to apply, but priority LGA's get 20 additional points.
- Grants are between \$20,000 (minimum) and \$10 million (maximum). Please note the Preparing Australia Program grant is managed by the National Recovery and Resilience Agency. For further information please check:

## **SEMC COMMUNIQUE**

#### **OCTOBER 2021 HIGHLIGHTS**

The State Emergency Management Committee (SEMC) met on 1 October 2021.

The key items from the meeting are summarised below.

#### **Discussion Items and Outcomes**

During the Wooroloo bushfires in early 2021, the State Support Plan – Animal Welfare in Emergencies was activated for the first time. The SEMC received a presentation from Pamela l'Anson and Brett Hopley from the Department of Primary Industries and Regional Development (DPIRD) on the activation process and outcomes:

- This was the first activation of the plan and the Committee for Animal Welfare in Emergencies (CAWE).
- CAWE has 27 members who promote communication, collaboration and the integration of animal welfare into emergency management. CAWE members include Department of Fire and Emergency Services (DFES), Department of Biodiversity, Conservation and Attraction (DBCA), RSPCA and Perth Zoo.
- During the Wooroloo bushfires an immense amount of support was given by the Australian Veterinary Association and individual vets, which SEMC and DPRID commended. There were up to 40 veterinary professionals involved daily over the 4 days of the activation.
- Feedback was given to the community at the evacuation centres on the animal welfare situation and surrounding individual properties and animals. This information was well received by the public and helped to assure their animals were safe and fed. This in turn reduced the number of requests to enter high risk areas, reducing resources required to manage public safety.
- After the bushfires a review of the State Support Plan was conducted, which identified 18 recommendations which DPIRD have already commenced actions on to improve their response for the upcoming high threat period. The SEMC acknowledged DPIRD's efforts and actions to implement, collaborate and improve the plan for future activations.

The SEMC Business Unit presented on the progress of the 2021 Emergency Preparedness Report, which advises the Minister on the preparedness of the WA emergency management sector. This annual report analyses information from a range of sources including the State Risk Project, significant incidents (e.g. Tropical Cyclone Seroja and Wooroloo Bushfires) and interviews with key leadership across the emergency management sector.

The SEMC endorsed the allocation of over \$1.3 million of the Mitigation Activity Fund Royalties for Regions funding to treat priority bushfire risks on Crown land under the care, control and management of eligible Local Government Authorities in regional WA.

The next meeting of the SEMC will be held on Friday 3 December 2021. Agenda items are to be submitted no later than Friday 12 November 2021.

#### **Community Disaster Resilience Strategy**

The Department of Fire and Emergency Services (DFES) and Australian Red Cross were awarded funding in 2019 to prepare a Community Disaster Resilience Strategy for WA.



The Strategy aims to increase the capacity of communities to cope with and recovery from the possible impacts of natural hazards, identify resilience priorities and guide the development of

programs and activities to address resilience gaps. The Strategy will align closely to the National Strategy for Disaster Resilience and the National Disaster Risk Reduction Framework.

Through stakeholder consultation, a Community Disaster Resilience Strategy Discussion Paper has been established. The next round of consultation on the Discussion Paper was officially launched at the WA Emergency Management Conference in Bunbury on 13 October 2021.

The consultation will ultimately inform the final strategy. DFES will be seeking feedback specifically on the proposed outcomes framework, transformational shifts, change initiatives and implementation roadmap.

Thank you everyone who has contributed to date to this important project. Your input plays a key role in assisting us to deliver a robust Community Disaster Resilience Strategy for Western Australia.

#### My Bushfire Plan enhanced for 2021/22 bushfire campaign

The 'How fireproof is your plan?' bushfire safety campaign will run again this year to raise awareness of bushfire as a personal risk and drive Western Australians to make a robust bushfire plan.

The My Bushfire Plan website and companion app launched last year have been updated with new features to make it even easier for all Western Australians to create, update and share their plan.

#### State Aerial Firefighting Fleet 2021-2022

#### The Australian Fire Danger Rating System

The Australian Fire Danger Rating System (AFDRS) Program is a national project working to design and implement a new AFDRS. The new AFDRS will combine the latest science, experience and data to strengthen the ability of fire authorities to accurately communicate bushfire danger and improve community safety. The new AFDRS is expected to be rolled out across Australia in 2022.

#### Changes to the Australian Warning System

The Department of Fire and Emergency Services (DFES) is joining with other Australian States and territories to implement the Australian Warning System (AWS).

AWS delivers a more consistent approach to emergency information by using a standardised set of icons to show hazard warnings on websites and apps, supported by clear action statements to keep people safe.

The AWS is being implemented in a phased approach with the first phase implemented in September 2021.

Leavers 2021 saw huge numbers attend, over 10000 well above previous years to the extent the event organisers ran out of wrist bands. This in itself brings unwanted crime where there were reports of leavers stealing wrist bands and some resorting to violence to take wrist bands.

Large lines were present at Dunsborough and Busselton, some leavers waiting many hours in line.

The event went smoothly with no major incidents to note, no Emergency incidents to report.

There were approximately 50 offences reported over the week, ranging from assaults to stealing offences. This is not unusual during a leavers event.

Some very minor protest activity for non-vaccinated leavers, one event arranged at Xcape at the Cape on the Monday night for non-vaccinated leavers. Nil issues to report.
