AMENDED RECOMMENDATION

That Council:

- 1. In pursuance of Part 4 of the Deemed Provisions of the Planning and Development (Local Planning Schemes) Regulations 2015 (the Regulations), adopts the Abbey South Structure Plan (Attachment B) for consultation, to be advertised concurrently with Amendment 55, as set out below.
- 1. Request written consent confirmation from the Western Australian Planning Commission that a Structure Plan may be prepared for Abbey South in accordance with Schedule 2, cl.15 of the Regulations.
- 2. Require the following modifications to Amendment No. 55 of the City of Busselton Local Planning Scheme No. 21 prior to advertising:
 - (a) Inserting 'Special Provision Area No. 76' to read as follows -

SP76	As identified on the Scheme map	Urban Development	1.	A single structure plan is to be prepared for the entire Special Provision Area.
			2.	In addition to the information to be included in a structure plan outlined in Clause 16 of the Deemed Provisions, the structure plan is to set out the following:
			i.	A water management report that takes into consideration the land to the south and addresses all water-related matters relevant to the proposal.
			ii.	Measures to manage risk from coastal inundation.
			iii.	Open space requirements.
			iv.	Measures to retain, manage, and enhance environmental values associated with the Special Provision Area including remnant vegetation, potential habitat for Commonwealth and State listed threatened fauna

species, ecological linkages and wetlands, within 'public open space', road reserves, and/or conservation areas (as identified on the Structure Plan). Such measures are required to also address linkages and connectivity with contiguous areas of similarly important remnant vegetation on land adjoining the special provision area as well as management measures to ensure the habitat functions of these areas are maintained and, where possible, enhanced.

- v. The provision of vegetated buffers to ensure appropriate visual screening and separation of development from main roads adjoining the Special Provision Area.
- vi. Measures to provide for the safe and efficient movement of pedestrians and cyclists to, from, and within the Special Provision Area, including crossings of main roads adjoining the Special Provision Area.
- 3. A Local Development Plan is to be prepared on Lots 12 and 402 Caves Road and Lots 14 and 15 Bussell Highway to address:
 - Location of car parking, pedestrian access and vehicular/service access areas for development where adjacent or located on Lot 402;
 - ii. Amenity of the locality and surrounds; and Landscape values and visual management considerations.

- 3. Subject to the modifications detailed in Part 3 2 above, in accordance with Section 75 of the Planning and Development Act 2005, adopt Amendment No. 55 of the City of Busselton Local Planning Scheme No. 21 (Attachment D) for advertising, for the purposes of amending the Scheme Map (Attachment E) by:
 - i. Replacing the 'Rural' and 'Conservation' zones over Lots 4, 12 and 402 Caves Road and Lots 14 and 15 Bussell Highway, Abbey with the 'Urban Development' zone; and
 - ii. Amending the boundary of the Landscape Value Area to align with the west, south and east boundaries of Lot 4 Caves Road, Abbey.
- 4. In accordance with Regulation 35 (2) of the Planning and Development (Local Planning Schemes) Regulations 2015, determines that Amendment No. 55 of the City of Busselton Local Planning Scheme No. 21 is a 'standard amendment' in accordance with r.34 of the Regulations as it is:
 - i. an amendment that is consistent with a Local Planning Strategy for the Scheme that has been endorsed by the Commission; and
 - ii. an amendment that does not result in any significant environment, social, economic or governance impacts on land in the scheme area.
- 5. Note that, as the Amendment is in the opinion of the Council consistent with Part V of the Planning and Development Act 2005 (Act) and Regulations made pursuant to the Act, upon preparation of necessary documentation, the Amendment be referred to the Environmental Protection Authority (EPA) as required by the Act, and on receipt of a response from the EPA indicating that the Amendment is not to be subject to formal environmental assessment, be advertised for a period of 42 days, in accordance with the Regulations. In the event that the EPA determines that the Amendment is to subject to formal environmental assessment, this assessment is to be prepared prior to advertising of the proposal.
- 6. Through agreement with the applicant, modify the Abbey South Structure Plan prior to advertising as follows:
- 6. Note that the City cannot adopt the Abbey South Structure Plan prior to the receipt of written consent from the Western Australian Planning Commission, as outlined in Part 1
- 7. Note that subject to existing delegation, it is envisaged that the Abbey South Structure Plan will be adopted for advertising, through agreement with the applicant, with the following modifications:
 - i. Incorporating vegetated buffers within the Structure Plan area to ensure sufficient screening to Caves Road and Bussell Highway;
 - ii. Applying a range of R-Codes to Lots 12 and 402 Caves Road and Lots 14 and 15 Bussell Highway, Abbey, to accommodate an increased diversity of development opportunities;
 - iii. Improving permeability of Lots 12 and 402 Caves Road and Lots 14 and 15 Bussell Highway, Abbey, through the modification to the proposed network of roads / paths / reserves; and
 - iv. Identification of a higher order cycle path through the Structure Plan area that connects to the City's existing and planned network.

8. Prior to implementing the above, require the proponent to prepare revised amendment documents consistent with the modifications set out in the Parts above.

REASONS FOR AMENDMENT

An amended recommendation is proposed to ensure that proper approval processes are adhered to. Currently, the zoning applicable to the Abbey South Structure Plan area does not provide a head of power required to prepare a structure plan.

The proposed Amendment No. 55 would address this by replacing the 'Rural' and 'Conservation' zones over Lots 4, 12 and 402 Caves Road and Lots 14 and 15 Bussell Highway, Abbey with the 'Urban Development' zone.

However, in order to progress the amendment and structure plan concurrently, the City of Busselton must first seek written consent from the Western Australian Planning Commission (WAPC) to prepare a structure plan.

Following the receipt of written consent from the WAPC, it is envisaged that the Abbey South Structure Plan will be adopted for advertising under an existing delegation.

At this stage the City cannot require modifications. Rather, the City will seek agreement with the applicant to modify the Abbey South Structure Plan prior to advertising in accordance with the officer recommendation.

It is noted that the City may still recommend modifications to the Structure Plan at the final adoption stage in order to address any outstanding matters.

AMENDED RECOMMENDATION

- undertake community engagement regarding the development of a new War Memorial Cenotaph at Rotary Park, on the basis of the attached concept designs (Attachments A, B, C and D); and Endorse the concept designs for the potential relocation of the War Memorial to Rotary Park as per Attachment A, for the purposes of further community engagement; and
- 2. On completion of the community engagement, request the CEO present a report to the Council detailing the outcomes of the community engagement, for a final determination on the relocation how to proceed.

REASONS FOR AMENDMENT

Amendments are proposed to clarify the scope of the proposed development and consultation, being the construction of a new War Memorial Cenotaph (and surrounds). The Memorial Wall at Victoria Square is proposed to remain in situ at this stage.

Officers have also amended the recommendation in response to concerns from some Councillors around the word 'endorse', with the intent being for community consultation to be undertaken on the basis of the concept designs (attached to the report), and for a further report to then be presented to the Council, for final determination on how to proceed. The amended recommendation seeks to reflect this.

This represents an exciting opportunity for our community to meet, engage and learn from Fremantle Dockers players including local talent Jye Amiss.

Through the promotion of external media (Channels 7, 9 & 10) we anticipate plenty of exposure and interest in this upcoming camp.

Due to the impact of COVID-19, the financial contribution provided by the AFL towards activities like the Community Camp has been heavily reduced, however the club values the impact and opportunity to engage with communities at a grass root level and are therefore seeking support to be able to proceed.

The Fremantle Dockers have requested funding support of up to \$5k from the City to assist with the safe operations of running the open training session for the public, including toilets, water facilities, security and traffic management.

Officer recommendation is to endorse the allocation of up to \$5k towards the Fremantle Dockers Football Club Community Camp, to be funded from the 2022/2023 Marketing Budget.
