7.2 Repairs and maintenance for Emergency Water Points in rural residential subdivisions – Mark Fisher

Blake Moore responded to 7.2

The cities funding for the Emergency Water Points is through our Engineering and Works department and the replacement of faulty/broken EWPs is an expensive exercise. The city plans to replace and rationalise the critical EWPs and tag the out of service points. The EWPs that are out of service will be tagged and if any brigade members come across water points that are faulty and not functional to please report them to the CoB.

7.3 Specifications for water storage at EWP's in new subdivisions – Mark Fisher

Mark Fisher suggested the CoB should have specifications and standards for EWP's for each suburb.

Blake Moore responded to 7.3

Please see attachment 7.3.1 and 7.3.2 for the images of the new mandatory water tank fitting applicable to all new subdivision. All new subdivisions are now required to have both fittings on their water tank.

The Standard that the City of Busselton will be using going forward will be a 100mm ball valve and a 100mm (4") male camlock fitting with a reducing adaptor to a 50mm (2") male camlock fitting that is chained to the 4" valve to prevent removal (away from tank) or losing of adaptor, at the base of the tank or 2 outlets as per attachment 7.3.2.

In line with Australian Standard 2419.1:2005 all new heavy tankers (4.4, 3.4 and 2.4s) are fitted with 100mm camlock suction hoses, and DBCA (PaWS) trucks, 1.4s and Light tankers are equipped with 50mm camlock suction hoses. By standardising these fittings it will allow all fire fighting vehicles to take water from these tanks in the event of an emergency without any delay. All brigade vehicles will be compatible to one of these two fittings.

9.1 Advanced Bush Fire Fighting Course - Blake Moore

9.2 Private property burns - Chris Payne

Due to covid restrictions it was asked whether private property burns are now permitted.

Blake Moore advised private property burns can be conducted as per the normal process and all application paperwork needs to be sent to the CoB for approval.

9.3 Communication with the public via SMS during bushfire season – Todd Johnson

Todd Johnson asked about SMS notifications being sent to land owners during Harvest Vehicle Movement bans implemented by the CoB.

Blake Moore advised the committee that the city has requested through ROAC for DFES to develop or investigate a mobile app to push a text notification to land owners. Updates will be provided throughout the process to the committee.

9.4 Burning of roadside verges – Peter Dawson

Peter Dawson expressed his concerns for the need for roadside verges to be burnt out and to have fuel load reduction and for the city to advise any contractors doing works on the verges that they need to be mindful during operations not to damage fence lines of private properties. The question was asked as to when roadside burning will come into place?

Tanya Gillett advised that the city engages an arborist to conduct much of the mitigation works to minimise the risk on road verges and that there are environmental aspects that the city needs to adhere to when maintaining road verges.

9.5 An environmental team debrief - Todd Johnson

Todd Johnson requested for the CoB environmental team to attend a BFAC meeting and have a discussion/debrief on the environmental requirements the city has to adhere to and how it works in with the city's bush fire requirements and legislation.

This idea was supported by the entire committee and Tanya Gillet is going to action this request and follow up with a request for a city environmental officer to attend the next meeting in September.

Burn Smart Campaign

The Burn SMART campaign was created after an Office of Bushfire Risk Management investigation into escaped private planned burns in the South West and Great Southern Regions in May 2018.

The campaign is not about discouraging people from conducting planned burns. Instead it aims to improve people's perceived personal risk and sense of accountability when lighting a fire.

It recognises that it is essential for private property landholders to take responsibility to reduce fuel on their property.

The Burn SMART campaign material includes regional radio and social media and online advertising. It is accompanied by educational resources developed by the Bushfire Centre of Excellence to guide landholders in undertaking planned burns. This information is available on the DFES Website and the Volunteer Hub.

VFRS Incidents

As is common this time of year Brigades have had several Road Crash Recue incidents including a Log Truck leaving the road and ending up on its side and a driver in a 4WD towing a caravan lost control and ended up with his vehicle on its side with the caravan lucky remaining on its wheels

There has also been an increase in structure fires which together with the colder weather and covid stay at home restrictions the likely reasons for this.

SES Incidents

The state had its first decent storm impact our region from the 5th to the 6th of May. This created some wide spread damage to both homes, businesses, infrastructure and caused the blockage of several roads from fallen trees.

DFES LSW had staff and volunteers on standby to assist in both incident management and running of the Regional Operation Centre in Manjimup.

Local SES crews received 52 Requests for Assistance (RFA). 35 were completed by SES teams, 17 cancelled/referred/rejected for various reasons.

Most calls were for roof damage or fallen trees, ranging from replacing the water tank inspection hatch for an elderly caller, to making safe and tarping an entire farm house near Donnybrook.

Storm 24-25/May

This even was the most severe in the past two years, with forecast winds to 125km/h. Across the Lower-South West region we received more than 50 Requests for Assistance (RFAs, or call-outs) from Sunday after through to Monday night. Approximately two-thirds of these were in the Busselton area (Yallingup to Capel); 10 in Augusta-Margaret River, and the remainder across the inland areas. The

storm caused structural damage to two properties, with widespread minor damage, uprooting of trees, loss of power, and subsequent loss of telephone and communications networks.

Approximately 80 SES volunteers responded during the incident, with Donnybrook, Busselton and Margaret River SES units remaining in operation for over 24 hours. The most common call-outs were for trees on houses/vehicles and for roof damage.

Storm 28-29/June

This minor storm resulted in 22 Requests for Assistance (RFA) across the region; with most (14 RFAs) from the City of Busselton area. Widespread minor damage with roof damage, trees blocking access and minor flooding.

Land search 30 June

33 SES volunteers from across the SW and LSW regions supported WAPOL in searching for a missing person swept off rocks at Wyadup.

Training

To keep our volunteers up to date we have been conducting weekly teleconferences to supply the latest Covid19 news and any changes in our operating procedures. These have proved to be very successful with a nearly 100% attendance by Brigades from both the VFRS and SES.

During the main stages of the Covid19 restrictions brigades had limited the activities on stations to essential checks and incident response only. Training and other meetings had been cancelled. Cleaning and social distancing measures were adopted with an audit of all PPE conducted. In the last few weeks we have been able to gradually retract these conditions allowing brigades to resume training and other activities, if they meet the social distancing guidelines.

The Region has had to cancel some of its courses due to Covid19, a plan was put into place to reinstate training and investigate possible alternative training options like utilising web-based platforms to deliver courses.

Several volunteers were required to complete their annual Breathing Apparatus refresher. Due to the restrictions with Covid19 this made it a challenge, so a trial web-based session has been conducted with great success.

An initiative in sending out training themes to volunteers with articles to read and videos to watch has also been implemented. This allowed volunteers stuck at home to still be involved in brigade training and maintain enthusiasm.

BGU training has now largely returned to normal with social distancing and good personal hygiene practices still needing to be enforced

Courses are being entered onto Eacademy with an emphasis on essential training as identified during a training needs audit with more courses becoming available every week.

Circular Updates

COLLIE FACILITY PROJECT

The facility will bring volunteers and DFES staff into Collie from all over the state to undertake emergency driving training. It will provide regional fleet maintenance and management, undertake new vehicle commissioning for emergency vehicles built in Collie, establish the state's first purposebuilt level 3 incident control centre (ICC), and provide ICT and radio communications frontline service support.

The tender for the facility construction was released 29 June 2020.

COVID-19: CURRENT SITUATION

In response to WA Health Department COVID-19 advice, the DFES Incident Response Team has supported the resumption of the SBGU activities including nonessential community-based activities like: • Building Inspections and • Community Engagement. These activities must still adhere to WA Health Department and DFES COVID-19 Guidelines. As guidelines change to suit the WA Government's COVID-19 roadmap, SBGU's can adapt their participation in these activities accordingly.

DFES Facilities and Vehicle Cleaning Guidelines for COVID-19 remains in place, the COVID 19 Incident Response Team have authorised the removal of additional facility sanitisation from 1 July 2020. Normal facility, fleet and equipment cleaning regimes should continue as should personal hygiene practices. In the meantime, we must continue to keep up physical distancing where possible and maintain good personal hygiene to better protect ourselves and the general health of our community

Bushfire Centre of Excellence welcomes first trainees

The Bushfire Centre of Excellence (BCoE) celebrated the commencement of three Aboriginal Trainees this month. The trainees will provide administrative support and help to deliver and promote the activities of the BCoE. This will include supporting the newly established Traditional Fire Program Alongside Traditional Fire Programs Coordinator Wayne Davis and Traditional and Cultural Fire Officer Clifton Bieundurry. The traineeship will take place over the course of a year with the possibility of an additional year of employment upon completion.

Drive Operate Appliance Introduction

The Drive and Operate a Firefighting Appliance (DOFA) qualification will be replaced with a Drive Operate Appliance (DOA) process. DOA assessments can be conducted by District Officers (DO), Area Officers (AO), Community Emergency Services Manager (CESM), Station Officers (SO) or a Brigade/Group/Unit (BGU) volunteer operational officer, subject to themholding the DOA qualification of the appliance/vehicle. All DOFA qualifications will be automatically updated to the appropriate DOA qualification. There is no requirement for you to complete a DOA on an appliance/vehicle when you had previously completed a DOFA qualification. DOA is required; for initial qualification on an appliance/vehicle type, or when that appliance/vehicle is superseded or has a cab/chassis variation.

ELECTRICAL EQUIPMENT HAZARDS

On arrival at an incident treat all electrical components, including poles and supporting structures as though they are energised. Crews must not contact any part of a power pole or other electrical equipment until isolation is confirmed by the energy provider. What has happened? While trying to retrieve a power pole identification number, a crew member approached and touched the wet pole, resulting in a mild electric shock. The pole had not been isolated.

DFES Regional Staff

Regional staff had split into two teams, this was initiated to restrict the potential of an outbreak in the LSW which could have affected DFES operational capability. The teams were rostered 2 days in the office and 2 days at home, minimising contact between members however still maintaining service delivery.

Since the easing of restrictions, we have now returned to our normal working arrangements. Manjimup District has had a change in titles for the fire managers,

DO Manjimup is now known as DO Nelson and AO South is now known as AO Warren/Blackwood Chris Sousa was successful in obtaining the position of AO Warren Blackwood. Bridgetown Shire is currently identifying a temporary replacement for Chris old job as the CESM for Bridgetown.

 BWD_076 Hemsley road Yallingup was set up for Ignition on 15/05/2020, but it was cancelled at the last minute again due to forecast windy conditions expected on Sunday 16/05/2020 (gusts to 50Km / hr)

- This would have also been a potential risk to manage again during the severe Cold Front front that arrived on 24/05/2020 a week later.
- This is the 3 season in a row that have ended with quite severe Cold Fronts with dry windy conditions arriving prior to the rain and an ongoing consideration for future Autumn burns with high risk / consequence.
- BWD_055 Treeton will hopefully address the number of arson Incidents in Vasse Plantation.
- BWD_133 Whicher is coming up to 9YO, is on the RUI, and is being completed to take advantage of the low fuels to the south ion McGregor Millbroook.
