To request a noise investigation, complete and return the enclosed 'Noise Investigation Request Form' and 'Noise Log Sheet' to enable the City of Busselton to process and investigate your noise concerns.

### Before Lodgement

The City of Busselton considers it reasonable that in the first instance you attempt to resolve the issue by talking with the party making the noise. Should this be unsuccessful or you feel uncomfortable doing so, the City can assist further. ### Log Sheet Requirements

To support investigation please record noise events over approximately two weeks however a shorter time frame may be sufficient depending on the severity. This information is used to determine the nature of the noise, detect patterns and identify possible action.

### Legal Action

In some cases, legal action may be necessary to resolve a noise matter. Evidence given by affected persons may be vital to achieving a successful outcome. Anyone lodging a noise investigation request may be required to give evidence in court should the need arise.

### Customer Request Management

If you have reported this issue online the customer request file will be closed and you may receive a notification. On receipt of the enclosed noise investigation request form and noise log a new customer request file will be created and allocated to an Environmental Health Officer to review.
