4.2 Oscar Negus, Deputy Chief Bushfire Control Officer, Hithergreen BFB:

Triple zero calls are being received during the winter months reporting bushfire incidents. This requires bushfire incident managers to respond to some calls which are determined to be unnecessary. A public awareness programme is required to inform the community regarding the reporting of bushfire especially during the winter months when the bushfire risk is very low. Attachment 7.1 Report to City of Busselton Bush Fire Advisory Committee meeting to be held on 13 September 2016

Matters to be discussed:

1. Sentinel Alert and Public Information - Report of the Special Inquiry into the January 2016 Waroona Fire

At the meeting of the BFAC held on 14th June 2016, the Committee recommended to Council as follows:

The City of Busselton conducts a survey to ascertain the level of community interest in the Capes Region for a Sentinel Alert System.

Shortly after that meeting, the Report of the Special Inquiry into the January 2016 Waroona Fire – "Reframing Rural Fire Management" was released.

The report goes into significant detail on the matter of public information and warning systems. In Chapter 10, Information, Alerts and Warnings, some 25 pages are devoted to this subject.

The majority of the report focuses on the operational aspects (timing, accuracy, completeness etc) of specific warnings issued during the fire, and whether these served the desired purpose of alerting the community to the dangers of the fire, or actually contributed to the overall uncertainty. The report also goes into the information provided at public meetings, on ABC radio and in other formats.

Whilst acknowledging numerous failings in timing, distribution and message content, the only Recommendation contained in this section is:

Recommendation 11: The Department of Fire and Emergency Services to investigate and adopt a system that will allow the public to opt in, monitor and receive, through a 'push mechanism', bushfire and other emergency warnings, maps and information using a wide variety of devices including personal hand held smart devices.

This recommendation is based on evidence to the Inquiry that in the 2016-17 financial year DFES proposes to establish a Digital Communications and Social Media Team to take advantage of new technology. It is also proposed that this team will be tasked with expanding DFES social media engagement, developing the CMS and also investigating and delivering an app for handheld devices. Whilst specific details of the app have not yet been finalised, DFES proposes to deliver the app by 2017-18.

In the closing paragraphs of this chapter of the report, the Inquiry makes the following comments about the importance of communications, but also the false sense of security that can be generated:

"Comments received in several written submissions to the Special Inquiry indicated that due to specific town sites not being mentioned in alerts, community members did not feel that action was required. The Emergency Alert Australia website advises individuals to not wait to receive a warning message before acting and this message is also promoted in the DFES Community Engagement Bushfire Strategy. The Special Inquiry endorses this message.

As the technology, timing and content of emergency information and warnings continue to be enhanced, so too the expectations of the community increase. In attempting to meet all of the (varying) needs of

community there needs to be a balance. There is a risk of a "learned helplessness". That is, some individuals will choose not to proactively seek information or to act on information until they are told or shown directly by the emergency services. Consistent with the theme of 'Shared Responsibility', the aim of warnings and advice should be to empower the public to act on their own, to the greatest degree possible."

The Special Inquiry considers that continued emphases should be placed on education around warning and alert meanings and limitations. Further, self-reliance and preparedness should continue to be encouraged for people living in bushfire prone areas.

In summary, the Report makes a recommendation that:

 DFES "investigate and adopt a system that will allow the public to opt in, monitor and receive, through a 'push mechanism', bushfire and other emergency warnings, maps and information using a wide variety of devices including personal hand held smart devices."

Given the content in the report relating to the difficulties around the current emergency warning systems, and that Sentinel Alert is designed to rebroadcast the DFES alerts direct into private residences, in the best interests of the Busselton community, information and advice will be sought from DFES in regards to the recommendations from the Special Inquiry by State agencies so that any system which may be provided in the City of Busselton is consistent with and complimentary to the emergency messaging services developed by DFES.

Matters to be discussed:

 Multi-agency preformed teams being established/finalised prior to the 2016/17 fire season. Based around previous P&W model, will have specific roles identified for local government / BFB personnel to ensure the local knowledge is imbedded into the IMT

- Blackwood District prescribed burning program 2016/17 comprises of 33 Spring burns (approx. 51,000ha) and 18 Autumn burns (approx. 59,000 ha). Not all area will be achieved but need to ensure sufficient east-west spread to maximise opportunities, when the right weather conditions and moisture profiles are available.
 - o Areas within the City are focused around Yallingup and Yelverton.
- Collins Tower (just south of Gracetown) will be manned on all days with an FDI greater than 100 and we will ensure adequate Spotter coverage on days with FDI's from 60 100.
- Conservation Employee numbers will increase in Margaret River and Busselton work centres, largely due to the changing nature of day to day works. Coverage across the District should remain similar to previous years.
- Additional equipment including Sign Trailer, Collar Tank trailer and a posi-trac is being acquired by the district to increased capabilities.
